## Requirements for the design of articles/theses for the journal "Youth Economic Bulletin of S. Kuznets KhNUE"

The journal "Youth Economic Bulletin of S. Kuznets KhNUE" publishes articles/theses of students and postgraduates of S. Kuznets KhNUE. Articles/theses submitted to the editorial office must not have been published or intended for publication in another periodical.

Articles/theses must comply with the journal profile and be accompanied by a list of authors and information about them in the form of a table indicating: the name of the responsible department of S. Kuznets KhNUE; surname, first name, patronymic of the author; title of the articles/theses; academic title, academic degree and position of the scientific supervisor; surname, first name, patronymic of the head of the department; the contact person and his/her telephone number. This table must be signed by the head of the department and sealed.

Taking into account the scientific profile of the journal, the editorial board accepts articles/theses in Ukrainian, English, French and German which make it possible to form an idea of the current state of the most pressing problems of economics. The presentation of the article/theses must be clear, understandable and meaningful.

## Rules for writing articles/theses:

**the title** of the article/theses should be short but informative. The title of the article/theses should not contain abbreviations;

the UDC index should be placed on the left under the title of the article/theses;

the author's surname and initials (no more than two authors) should be in the file under the title of the article/theses in the language of the article/theses; the abstract should be in Ukrainian and English, starting with the abstract in the language of the article/theses (25 - 40 words); **keywords** must be in Ukrainian and English (3 - 7 words). If the article/theses is written in French or German, an abstract and keywords in this language are additionally submitted:

the text of the article/theses should be on 4-6 pages with conclusions and prospects for further research in this area. The article/theses must be fully prepared using the Microsoft Office Word editor. The text of the article/theses must be placed on sheets of A4 paper (210 x 297 mm). Font Arial, size 14, line spacing 1.3, margins: 2.0 cm left, 2.0 cm top, 2.0 cm right, 2.0 cm bottom. The page number should be indicated at the bottom of each page of the original.

The text of the article/theses must comply with the requirements of the Resolution of the Presidium of the Higher Attestation Commission of Ukraine dated 15.01.2003 No. 7-05/01 (Bulletin of the Higher Attestation Commission of Ukraine, 2003, No. 1) and

contain the following elements (their names are not indicated in the text of the article/theses):

- > statement of the problem in general form and its connection with important scientific or practical tasks;
- > analysis of recent research and publications in which the solution to the selected problem has been started and on which the author relies, highlighting previously unresolved parts of the general problem to which the specified article/theses is devoted;
  - formulation of the objectives of the article/theses (statement of the task);
- > presentation of the main material of the study with a full justification of the obtained scientific results;
  - > the study conclusions and prospects for further research in this direction.

The text, all digital data and materials for the article/theses should be carefully checked by the authors. Commonly used terms that are often found in the text should be presented in the form of an abbreviation with deciphering at the first mention. Schemes and flowcharts should be placed after the first reference to them in the text. All figures and tables should be accompanied by a title. All figures and diagrams should be designed in Microsoft Word or Microsoft Visio. Graphs, histograms, diagrams in Microsoft Excel should be available for correction and provided as a separate file. Tables in the article/theses should be used only if they contribute to the conciseness of the presentation or the information cannot be presented in the form of graphs or histograms. Formulas should be designed in the Microsoft Equation formula editor;

**references** should contain 5-10 sources cited or used in the article/theses, which should be numbered in the order in which they are mentioned in the text. References to the source should be given in square brackets, for example [1, p. 3–7]. The list of references should be given at the end of the article/theses as a bibliographic list of sources in the original language in accordance with DSTU GOST 7.1:2006.

The article/abstract is submitted to the editorial office *in the form of a file* on electronic media.

Authors of articles/theses and scientific supervisors of the relevant department are responsible for the correctness and accuracy of the data and facts they provide, as well as for placing in the article/theses data that is not the subject of open publication. Responsibility for the quality of the article/theses and the absence of plagiarism in it (no more than 20 %) lies entirely with the scientific supervisor of the author of the article/theses.

On the last page of the manuscript, there should be sealed personal signatures of the author (authors), scientific supervisor, head of the leading department.

In case of reprinting materials, a reference to the journal "Youth Economic Bulletin of S. Kuznets KhNUE" is mandatory.

The editorial board of the journal "Youth Economic Bulletin of S. Kuznets KhNUE" hopes for fruitful cooperation with the authors.

Placing an article in the journal "Youth Economic Bulletin of S. Kuznets KhNUE" is paid.
