<b>Learning forms and methods</b>	
<p>The university employs a 100-point cumulative grading system to evaluate the learning outcomes of its higher education students. Ongoing assessment takes place during lectures and practical sessions, aiming to assess the student's preparedness to perform specific tasks. This is evaluated by the total number of points earned. The final assessment includes semester control, which is conducted in the form of a differentiated pass. The maximum number of points for the ongoing evaluation during the semester for a subject with a differentiated pass form of control is 100, while the minimum possible number of points is 60.</p>	



Ongoing assessment includes the following control measures: topic-based tasks, quick tests, and control works.
