**Assessment system of learning outcomes**

Control measures include:

current control is carried out during lectures and practical lessons and is estimated by the sum of the points scored (minimum amount - 15 points, maximum amount - 40 points);

modular control - a written modular tests after studying the material from the logically completed part of the discipline - content module (minimum amount - 10 points, maximum amount - 30 points);

final control is carried out in the form of a credit as the sum of the points scored in the discipline (minimum amount - 35 points, maximum amount - 100 points), is defined as the sum of points for the student's progress in the current control, including written modular tests (modular and final (minimum amount - 10 points, maximum amount - 30 points)). Modular and final tests points are added to the sum of the points scored for student's current control. The credit is given on the results of the student's work throughout the semester.
