A student should be considered certified if the sum of points obtained from the final / semester performance test is equal to or exceeds 60. The final grade in the discipline is calculated taking into account the points obtained during the test and the points obtained during the current control of the accumulative system. The total result in points for the semester is: «60 or more points – credited», «59 or less points - not credited» and is entered in the test «Statement of performance» of the discipline.
