#### Learning outcomes assessment system

### **Discipline policies**

Policy on the implementation of tasks later than the deadline: the implementation and defense of tasks in the discipline are in accordance with the schedule of the educational process in the discipline, which is presented in the work plan (technological map). Deviations from the schedule do not affect the evaluation results.
