Assessment system of learning outcomes

Control measures for the discipline include: current control during lectures and practical classes, estimated by the amount of points scored (minimum - 15 points, maximum - 45 points); modular control is carried out in the form of a written test after studying the material of the content module (minimum - 5 points, maximum - 20 points); final control in the form of a test in the discipline (minimum - 60 points, maximum - 100 points), is defined as the sum of points for the student's
