Assessment system

Assessment of higher education seekers` learning outcomes is carried out by the university according to the cumulative 100-point system

Current control is carried out during lectures, practical, laboratory and seminar classes and aims to check the level of the level of readiness of the higher education student to perform a specific job and is assessed by the amount of points scored: the maximum amount is 60 points; the minimum amount that allows a higher education student to take an exam (examination) - 35 points.

The final control includes semester control and certification of a higher education student, which is conducted in the form of an exam.

The maximum amount of points that a higher education student can receive during (exam) is 40 points. The minimum amount for which an exam (examination) is considered considered passed is 25 points.
